

Dear Future Partner!

Regarding your request we stay at your disposal with the following services:

- Customs services: Report import and export customs clearance via electronic way in the course of customs proceedings with minimal contribution of the customs office. Fully comprehensive import customs proceedings that include customs law representation. Our company has VAT self assessment permit, thus indirect representation allows our partner release for free circulation without paying import VAT. In this case the partner on the appendix of the quotation declare the assingment of the tax deduction rights. Regarding duties to be paid, RTEH Ltd. does not have deferred duty payment permission, in this manner the amount of the duty shall be paid toward our company on a weekly basis. Price of customs proceedings is the part of the quotation.
- Environmental protection product charges: In case of purchased products from an other member state or from a 3rd country, for the packaging and in some cases for the product environmental protection product charge has to be paid. Both in product charge record, declaration and expert consultation we stay at our clients' disposal.
- Intrastat data report: Member state import and export turnover report toward KSH.
 This report has to be done until the 15th day after the month concerned.
- EKAER (Electronic Trade and Transport Control System) service: Fully comprehensive administration of data recording, modification and transport locking in the Electronic Trade and Transport Control System.
- Temporary custody: from the 1st of May 2016 there is possibility to keep goods in temporary custody for 90 days, that gives opportunity for stock level optimalization.
- Excise services: Bonded warehouse services, tax stamping, tax stamp accounting, handling EMCS system, storage of excisable products, EKO, TKO documents fill out, inbound
